THAT TITLE 18, 21, 26 DID NOT PASS THE QUORUM
CLAUSE OF THE CONSTITUTION AND ARE NOT LAW**

COMES NOW; James Timothy, of the Turner family, a Secured Party Creditor, hereinafter referred to as the "Accused," a native- born American, One of We the People of the Alabama State Republic, a non-Fourteenth Amendment United States citizen, requesting that the Court install these documents and enter them into the court record as evidence or exhibits for the jury.

The Department of Justice has omitted IN A LAW SUIT that Title 18, (Public Law 80-772) of the Criminal code was never passed by the 80th Congress in a case that was filed by the Spire Law Group This law firm has filed a Verified proof of claim in the Court of Appeals for the District of Columbia on August 27, 2012. The D.O.J. and its agents in that case have refused to answer and have agreed to the Summary Judgment that was presented in that case. Since Title 18 includes the only authorization to allow federal courts jurisdiction in any criminal cases, whether Title 18, Title 21, or Title 26, see 18 U.S.C. Section 3231.
