Be it known that we are the Republic for the United States of America. We are NOT Republic States in union or any variation thereof. Republic States are nations unto themselves and would indicate that they are a coalition of independent nation States in union. This is the battle which President Turner continually tried to educate the People about; Our Republic is a Union of free States. Therefore we the Republic for the United States of America wish to make it known; that we are in no way associated with the Republic States in union or any variation thereof nor are they affiliated with us.

Be it further known; since December of 2012 a small group of former House of Representatives members has claimed to have convened our House without the Senate. They have proclaimed themselves to be the Republic States congress. As I stated previously, the Republic States have nothing do with the Republic for the United States of America or our Congress. Our constitution does not permit this unlawful act (Article 1 section 5 clause 4.) Over the past few months they have convinced a few others to join them and have brought confusion to the People of the Republic.

Any and all claims that they may attempt to make as to having any jurisdictional authority over any individual or government personnel of the Republic for the United States of America is invalid and we have no other means to communicate with them as they have not established any type of embassy or other forms of communication with us. We do wish them well in their endeavor to be recognized as an independent Republic.
