### Whose Government is this anyway?

**March 6<sup>th</sup>, 2014 Barack Obama issued an executive order dealing with an issue half a world away in Ukraine.** He claims this is creating a national emergency for the United States. That's odd! How can people fighting for freedom and independence cause a national emergency for the U.S.? Maybe there is a little more to meet the eye than we the people of America are aware. ***Sec. 7. For those persons whose property and interests in property are blocked pursuant to this order who might have a constitutional presence in the United States, I find that because of the ability to transfer funds or other assets instantaneously, prior notice to such persons of measures to be taken pursuant to this order would render those measures ineffectual. I therefore determine that for these measures to be effective in addressing the national emergency declared in this order, there need be no prior notice of a listing or determination made pursuant to section 1 of this order.***

If this sounds confusing, it should. Where is due process of law that is guaranteed by the constitution? However, the item that really jumps off the page at the reader is, “who might have a constitutional presence in the United States” Wait a minute! Doesn’t Mr. Obama have a constitutional presence in the U.S.? He said he did. To have a constitutional presence would mean that one’s position or status of authority is grounded in the constitution. In other words they have a right or duty to be there.

Since the peoples’ right to be here is an unalienable right from God, and the preamble establishes the people as the authority to create a constitutional presence, what is he talking about?
